


2	7/1	 This road sign: Indicates a place designated for parking of road vehicles, serving people with permanent disabilities Warns of possible occurrence of road vehicles, serving people with permanent disabilities Prohibits the movement of road vehicles, serving people with permanent disabilities Indicates a road line for road vehicles, serving people with permanent disabilities
2	8/1	Is the presence of the driver near the vehicle obligatory, when he has stopped for a stay?
2	9/1	 A vehicle is in a stay position when stopped for a limited time: for boarding of passengers for getting off of passengers for loading and unloading operations in the presence of the driver waiting for the arrival of a passenger
2	10/1	The vehicle which has stopped for a stay must: not stop the passing of other vehicles have the engine running switch on the low-beam headlights


